Post-qualification of the lowest calculated bid shall be immediately conducted thereafter.

All particulars relative to Eligibility, Technical and Financial Evaluation, Bid Security, Performance Security, Pre-bidding Conference, Evaluation of Bids, Post-Qualification, and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR).
